### **In this job, you would be responsible for:**

- Serving as an accounting department of one and performing all aspects of accounting and financial reporting.
- Fiscal stewardship for the organization, including planning, developing, organizing, implementing, directing and evaluating the organization's fiscal function and performance.
- Periodic budgeting, payroll, accounts payable, accounts receivable, financial statement preparation, state regulatory reporting, and finance and accounting support for specific development projects.
- Calculation and payment of state taxes, monthly federal taxes, medical premiums, and retirement withholding and preparation and submission of quarterly payroll reports, W-2s, and 1099's.
- Preparation of bank deposits, cash management and credit card reconciliation.
- Management of the financial requirements for cooperative agreements and grants.
- Effective communication and collaboration with the BSED team, Boards of Directors and community stakeholders to deliver accurate and timely financial information.
- Performing analysis and providing strategic financial input and leadership on matters affecting the organization.

- Graduated from an accredited four-year college or university with a degree in accounting. (CPA preferred, but not required.)
- At least five years of accounting experience in government and/or nonprofit organizations.
- Experience managing financial requirements for cooperative agreements and grants preferred.
- knowledge of current governmental and non-profit GAAP accounting theory, principles, and practices.
- ability to demonstrate high ethical standards and personal integrity.
- Audit experience preferred.
- Strong oral and written communication skills.
- Excellent personal effectiveness and time management skills.
- A combination of experience and education equivalent to the knowledge, skills and abilities necessary to perform the work at a high level will be considered.
