## 1. Build the Billings entrepreneurship ecosystem to support new, innovative and diverse business startups

- Master Plan, complete, \$90k secured by BSED
- Coulson Park development strategy still underway (Yellowstone River Bridge delayed Phase One work); work to begin spring 2024; BSED/donors funds to support phase one development - \$360k grants, \$261k in pledges and contributions
- Comprehensive funding/development plan approved by Council (May 2023), voters did not approve \$140 million plan, with rec center investment
- Working on incremental approach with focus on Coulson Park, Stage Coach Trail, Billings Skate Park, North Park, and potentially South Park

## COMMUNITY DEVELOPMENT

### HIGHLIGHTS

#### **Brownfield Program**

- Assessment Grant, 6 Phase I assessments have been completed on downtown properties and one assessment is in progress. There are 3 Phase II assessments in progress.
- Revolving Loan Fund Grant (\$1 Million secured), currently working on the initial setup of the program (guidelines, structure, etc.). We published a Request for Qualifications (RFQ) for Qualified Environmental Professionals (QEP) and received responses from several firms. After evaluation and ranking of the responses, we will be seeking approval to hire a QEP and complete the initiation of the program.
- Education and Community Outreach, we conducted education and community outreach to Laurel City Council, the Laurel Urban Renewal Agency (LURA) members, and to property owners and community members.

**City/County Tax Abatement Program | W**orking with the County and the City of Billings on reviewing current local resolutions on tax abatements to provide clear and concise direction for the application and decision-making process. **3** tax abatement applications have been approved through the program. A newly created equipment tax abatement program was created through the Legislature for Class Eight equipment. One tax abatement application has been completed through the new program.

**Lockwood Industrial Park (TEDD) |** The development of shovel ready industrial sites has many steps, the creation of the Targeted Economic development District, planning documents, preliminary engineering reports, consensus building, interlocal agreements, and securing funds. Today, we are working with the County, LWSD, KLJ, and Morrison Maierle to secure grant funding through the US Economic Development Administration to complete the initial stage of water and sewer infrastructure to the TEDD area.
