# Sysco Montana, Inc.

Company Location: Billings, MT

**Founding Year:** The Montana corporation was registered in 1988, but its parent, Sysco Corporation, was founded in 1969 in Houston, Texas. The company has locations in 90 different countries.

Sysco is the global leader in selling, marketing and distributing foods and non-food products to restaurants, healthcare and educational facilities, lodging established and other customers around the world.

#### **Services Overview:**

Billings APEX Advisors assisted the company with untangling its expired SAM registration. The company had lost access to it and could not get paid on orders that had been placed by DoD. It took several meetings to gain access to the registration, correct the legal name and get the registration active again. Companies cannot get paid if SAM is expired. Since APEX helped the company, it has collected \$449,885 in back payments.

# **PROGRAM IMPACT**

During FY 24, companies assisted by MT APEX Accelerator's six locations statewide secured \$210,836,237 in federal, state and local contracts. Of this, \$49 million to companies in the Yellowstone County/Eastern MT region and \$30 million to companies in BSED's SW MT remote location. This location covers a seven-county region including Gallatin, Silver Bow & Lewis & Clark. APEX advisors (statewide) held 53 training events with 1,011 in attendance and provided 3295 hours of advising to 1194 unique businesses.

# Rural and Tribal Environmental Solutions, Inc.

Company Location: Billings, MT

Founding Year: 2004



The company provides environmental, air, water & solid waste management consulting and on-site technical assistance to underserved populations across the United States. The company aims to bolster environmental equity to tribes and small rural communities and, support those entities to empower themselves to create a healthy and prosperous environment.

#### **Services Overview:**

The company first came to MT APEX (then PTAC) in 2004 for federal registration assistance, government contracting education and assistance with obtaining a GSA Schedule. The company has returned for services as needed, and over the last twenty years has become an extremely successful federal contractor. Since 2004, the company has secured \$7.8 million in federal contracts with EPA, BLM, GSA, USDA, DoD and Indian Health Services, primarily through sales on its GSA Schedule. More recently, Billings APEX advisors have been assisting the company with renewing its 20-year GSA Schedule so it can continue to provide solutions to the government.

# **Caring Hands Veterinary Hospital**

Company Location: Billings, MT Founding Year: 40+ years



Caring Hands Veterinary Hospital is an AAHA-Accredited veterinary practice offering a full suite of preventive and general animal care, including emergency services, breeding services, surgery, pharmacy and boarding for dogs, cats and birds.

#### **Services Overview:**

SBA 504 financing in partnership with Western Security Bank, assisting the borrower with the purchase of commercial real estate, renovations and equipment financing for their business expansion into a new, larger facility. The SBA 504 loan program provided this growing, Woman-Owned business, with minimal down payment and a below market, fixed rate note on 40% of their project financing. Working with Big Sky Finance, the borrower purchased a previously vacant building and renovated it into a state-of-the-art veterinary facility.

"In the summer of 2019, after purchasing Caring Hands that January, it was already becoming clear that something had to give. We simply did not have the space to respond to all the folks and their pets coming though our door. Buying land and building new seemed cost prohibitive. Instead, we found an existing structure vacant just blocks away. But about the time we were ready to make a move COVID-19 hit and we actually had to close our doors for eight weeks. By the time we were back on our feet construction costs had sky-rocketed making relocation impossible. But we never lost hope. Our staff worked hard, and doubled in size, we secured an architect who was willing to listen and able to convert our dreams into a floor plan, and with the help and guidance of Kris Eklund at Western Security Bank we were introduced to Big Sky Financial—our wildest dreams and aspirations coming to fruition in a little over six months.

It's still scary. And there are days we ask ourselves, "How did we pull this off?" Because we had TREMENDOUS HELP from people who knew business, who knew how to help us believe in ourselves, and how to get this thing done. Amber and I, and our whole staff, cannot thank you enough! #### **Services Overview:**

Working with Big Sky Finance, in partnership with First Security Bank of Missoula, borrower utilized the SBA 504 loan program for the purchase of commercial real estate and equipment for their expansion into the Denver, CO, market. The 504 loan program provided Hunter Bay with 10% equity injection and below market, fixed rate financing. The lower down payment allows for the preservation of cash for continued operations as the business grows.

Apricot Lane is a women's clothing boutique that creates a unique adventure and shopping experience that captures the look and vibe of their local area. They have new arrivals almost daily, so shopping at Apricot Lane is always a new discovery and truly an affordable "unique boutique" experience!

#### **Services Overview:**

The SBDC provided a business plan template and spread the historical financials of the business. Lorene Hintz helped with the cash flow projections, reviewed the business plan, and got Katherine ready to visit her lender. Kat's experience as the manager and buyer for the business strengthened her credibility with the lender and led to financing. Kat bought the business and inventory for \$440,0000, was awarded a \$440,000 loan from Yellowstone Bank and brought \$100,000 of her own funds for franchise fees and working capital. A grand reopening was held in March to celebrate new ownership and recently celebrated the 13th anniversary of the Billings location.

Casual Space is not just a gathering place; it is a vibrant hub that fosters community connections and supports local entrepreneurs. Alana, the visionary behind Casual Space, is driven by her passion for bridging the gap between making friends and connecting with like-minded individuals. The space accommodates more that 10 vendors, offers a diverse range of classes, workshops, and game nights, effectively achieving her objective of fostering a vibrant community gathering space. Notably, Alana also obtained a gaming license to host BINGO and Bunko night, further expanding the variety of events at her venue. Continuously attuned to client demand, she consistently introduces new events to enhance the community experience.

Alana approached the SBDC seeking financial support for her business venture. However, after a careful analysis of her financial projections and business plan, Kayla Vokral discovered that her startup expenses were lower than expected, allowing her to launch her business without incurring any debts. Kayla worked with Alana to help her understand her numbers, budget for her business, and build her business model, which was relatively complex due to local vendors renting booth space and her plans to hold various events, classes and workshops. With SBDC guidance. Alana successfully bootstrapped her business. and we provided her with the tools and knowledge to succeed.

The company is engaged in the digital arts: photography, videography, and film. Leon Clayton, the founder is an avid photographer and travels extensively in pursuit of the next best image.

#### **Services Overview:**

The Big Sky Veteran Business Outreach Center serves veteran entrepreneurs in MT, UT, and WY.



We created a cooperative process with the VA Veteran Readiness & Employment (VR&E) Department that utilizes its existing "self-employment track" that supports funding for disabled veteranowned businesses. This unique process provides the VR&E expert business input as they make their decision to provide seed funding for veteran-owned businesses. In late 2021, the first disabled veteran-owned company to make use of this process was Elsewhere Media Productions, founded by army veteran, Leon Clayton. With VR&E funding he was able to accelerate the growth of his company and recently co-directed and produced a short film that was nominated for three awards by the Utah International Film Festival, the Couch Film Festival, and the Zepstone Film Awards. He won at Zepstone for Best Thriller Film.

Starting in 2011 with a focus on quality, structure and color, Gargoyle Queen Reptiles has grown into one of the most sought-after breeders in the US and ships their unusual pets all over the world.

#### **Services Overview:**

Kylie Koskan, the owner of Gargoyle Queen Reptiles attended the 10-week SLCC/VBRC Women Veteran STRIVE business course that was created & taught by the director of the Big Sky VBOC. The course focuses on the growth of the veteran entrepreneur's business and ends with a presentation or pitch to a panel of businesspeople. Kylie's presentation generated substantial interest because of the projected growth from \$90,000 to over \$200,000 based on current inventory.

# **Yellowstone County Summer Jobs Program**

This workforce development program is a venture of AJAY MT out of Helena. In Yellowstone County, Big Sky Economic Development has been the lead of this program for the past three years in partnership with committee members from the Billings Chamber of Commerce, School District 2, Montana OPI, and Reach Higher MT. The program matches participants with a paid position, provides a paid foundational work skills training, and connects students with an adult mentor for the summer. SJP participants are high school students and recent graduates eager to develop their work skills and explore their career options. Participating area businesses (in all industries) and community organizations help strengthen the local economy by connecting youth to meaningful work experiences.

#### **Program Impact:**

This year, BSED led this program to recruiting 40 students to apply to participate, **34 students** to completing paid work skills training and working with a professional mentor for the summer, and 28 students to work for 20 local employers. This program involves student and host employer recruitment in the early spring, interest interviews, work skills training, employer, and student matches in the late spring, conducting employer and mentor training in the early summer. Big Sky Economic Development then works with employers, mentors. and students throughout the summer to support them through their summer employment.

# **Campus Billings**

This talent retention program is designed to build connections with interns working in Yellowstone County. The goal is to bring together student interns from all industries in Yellowstone County to connect them to each other, and to all the amazing reasons they are better off in Billings! The program is put on in partnership with the Billings Chamber of Commerce.

#### Program Impact:

This year, Campus Billings has 30 interns participating from local businesses across the county.

With grants totaling \$1.5 million, BSED offers environmental assessment and cleanup opportunities to assist in the redevelopment of properties in Billings and Yellowstone County. Eight Phase I and four Phase II environmental assessments were completed in fiscal year 2024.

Space2Place

With 44 placemaking and art projects funded since 2018, BSED's Space2Place program continues to incrementally transform and beautify our communities. Six new projects were funded this year, including Raza Unida's cultural art project at South Park.

Lockwood TEDD

BSED continues to assist Yellowstone County with the development of a planned industrial space along the Billings Bypass north of Lockwood. Current efforts include the extension of water and sewer infrastructure to that area.

Thriving Communities Grant

Partnership with the Native American Development Corporation and Seventh Generation Intertribal Center on a US Department of Transportation Thriving Communities technical assistance grant to develop a plan for a more welcoming and inclusive community. Hosted Let's Talk Cultural Conversation which brought together many community partners to discuss bridging cultural divisions.

Tax Abatement

BSED administers the Tax Abatement program for Yellowstone County and the City of Billings, completing three new real property tax abatements and six new manufacturing equipment tax abatements in fiscal year 2024.

**SSBCI** 

BSED secured \$530,000 in State Small Business Credit Initiative (SSBCI) funding to provide loans to area businesses.

# **Rocky Vista University College of Veterinary Medicine**

Company Location: Billings, MT

Yellowstone County will be home to Rocky Vista University College of Veterinary Medicine and College of Osteopathic Medicine (RVU), led by experienced veterinary industry leader Bob Murtaugh, DVM, MS.

After a national search, Montana's first veterinary school is coming to Billings, bolstering Education as our county's 7th largest industry and our growing medical education ecosystem. This investment will provide a critical workforce pipeline to support veterinary clinics across the region with the next generation of employees/owners and provide high-quality care for our vast ranching community. RVU is working with the Yellowstone Valley Animal Shelter as they expand into a new state-of-the-art facility with the possibility of building a low-cost vet clinic, dog park, and other services for our community. Plans are underway for RVU to build a new state-of-the-art educational facility on the same campus as the College of Osteopathic Medicine on Billings' West End.

# **New Airline: Sun Country Airlines**

Big Sky Economic Development, in partnership with the Air Service Committee and Billings Logan Airport (BIL), welcomed Minnesota-based Sun Country Airlines for direct service from BIL-MSP in June of 2024. This seasonal, twice-weekly service increases connectivity to a high-demand market during the summer months.

#### **Services Overview:**

Big Sky Economic Development is an active member of the Air Service Committee and in partnership with BIL, worked closely to host Sun Country Airlines in Billings and travel to Sun Country headquarters in Minnesota.

**The timeline:** Seasonal, twice weekly service (June-August) **Partners:** BIL, Billings Chamber of Commerce, Visit Billings, Montana Department of Commerce

## **PROGRAM IMPACT**

#### **Taking Flight**

- > 1. Flights are scheduled to be up 13% July December versus the same months in the prior year.
- > 2. Seats are scheduled to be up 19% July December versus the same months in the prior year.
- 3. Alaska Airlines BIL-SEA flights and seats are scheduled to increase 17% July - December versus the same months in 2023.
- A. Allegiant Airlines BIL-LAS capacity is scheduled to be up 18% July - December versus the same months in 2023.
- > 5. United Airlines BIL-DEN capacity is scheduled to be up 17% July through December versus the same months in 2023.
- 6. BIL has served approximately 10% more passengers (+41,075) during the first half of CY 2024 than were served during the same period in CY 23.

Big Sky Economic Development chairs the Communications Committee for the Billings Air Service Committee (ASC), comprised of BIL, Billings Chamber, Visit Billings, Big Sky Economic Development, and community leaders.

In this role, Big Sky Economic Development has created a cohesive ASC brand and published three quarterly newsletters in partnership between Recruitment and Engagement.

#### **New Business Recruitment Strategy**

 Implemented a new Business Recruitment Strategy, actively working with clients in Accommodations, Manufacturing, Retail, Energy, Healthcare, Housing, Entertainment, Industrial, and Higher Education.

Streamlined Recruitment Process in 4 key areas: Downtown Housing, In-Fill Development, Opportunity Areas across our County, and Key Industry Recruitment.

Billings has become a Medical Education Hub with six existing or planned institutions of higher education in our County - Montana State University-Billings, Rocky Mountain College, MSU College of Nursing, City College, Rocky Vista University College of Osteopathic Medicine, and Rocky Vista University College of Veterinary Medicine.




## Allocation of Resources
